CYSD Way

Background/Context


A number of development schemes and programmes are being implemented in the state. However, lack of people's participation at various levels of programme planning and implementation, lack of transparency in the operation of the schemes, and inadequate monitoring mechanisms have not been able to demonstrate desired outcomes and impact. The ultimate aim of good governance and inclusive development is to monitor how effectively the processes and institutions of governance are fulfilling their commitments to the citizens, and ensuring delivery of public services right up to the excluded and marginalized sections of society. For every programme, there is a structured monitoring system in place. But, that is part of the government mechanism and the community members are hardly part of this process, and the monitored findings are not shared among them. This results in exclusion of community opinion and voices in the development initiatives undertaken by the government. Thus, the need for citizens to engage with the Government's service delivery processes and mechanisms, particularly on the issues of quality of these services and whether they are reaching those for whom they are intended, was realized.

In recent years, increased opportunities to use participatory data collection and analysis tools combined with enhanced space and opportunity for citizen engagement with the state, widened the scope to incorporate social watch or social accountability practices right from the community level to higher-ups – through establishment of solid evidence bases and direct dialoguing and negotiations with government office holders. These include; participatory planning, citizen-led monitoring and evaluation of public services through Social Audit (SA), Citizen Report Card (CRC), Community Score Card (CSC), Participatory Expenditure Tracking (PET) and many others.

The Journey of CYSD in facilitating Social Watch

CYSD believes that participatory governance becomes a reality only when strong, aware, responsible, and vibrant citizens and citizen groups come forward and actively participate in decision-making processes. With this premise, CYSD has been striving hard to build the capacity of the citizens on how to exact transparency and accountability in various processes and institutions of governance at all levels. Developing and promoting different kinds

of social accountability tools and processes for empowering people to undertake citizen-led monitoring in governance schemes and programmes constitute the key pursuit of the centre. The social watch processes have been useful in contributing effectively to more informed policy designs and effective service delivery.



Steps

- 1. Developing Citizen Leaders
- 2. Formation of People's Watch Groups and their capacity development
- 3. Establishment of Citizen Assistance Bureaus at the community/GP level
- 4. Development of People-led Plans
- 5. Roll out of the Tools and Processes of Community-Led Monitoring (CLM)
- 6. Periodic interface and reflection between the service users and the service providers
- 7. Development and dissemination of knowledge products

The larger vision is to institutionalize the process of Social Watch as a collaborative means of improving people's participation in the governance processes and institutions, enhancing transparency, accountability and responsiveness within the same and improving the quality and reach of public services and schemes. Based on the above-portrayed rich repertoire of expertise and experiences in promoting active citizenship and social watch tools and processes, CYSD envisages a pivotal role for developing a full-fledged action framework and institutional mechanisms to roll out Social Watch in the State.

CYSD has a dedicated Technical Support Group (TSG), adequately equipped to provide technical support to all kinds of community level processes starting from people-led planning to citizen-led monitoring, audit and other ancillary watch processes. The unit has the necessary competence in developing need-based IEC materials, training modules, field level guidebooks, and learning documents. The unit can build an enabling environment of mutual trust and sharing between the service users and the service providers, provide necessary training and orientation to the identified Citizen Monitors/ Social Watch Facilitators, develop user-friendly resource materials, and provide handholding support at the ground level in this process.
